CODE OF CONDUCT



THE FOLLOWING CODE OUTLINES OUR REQUIREMENTS FOR GUESTS' CONDUCT ON AND OFF THE ROAD AND IS DESIGNED TO MAKE EVERYONE'S TOUR AS ENJOYABLE AND RELAXING AS POSSIBLE.

Any conduct that breaches this code could result in your removal from the tour and Mulga Bicycle Tours will not be liable to refund the cost of the tour or any expenses this removal incurs.

LEGAL REQUIREMENTS

All guests are required to observe the law wherever we go, both on and off the bike. Failure to do so will result in removal from the tour.

Guests must follow all traffic rules and road rules. This means you have the same responsibilities as drivers and must obey all traffic signals such as red lights, stop signs, give way signs, etc., just as you would driving a car. Additional road rules for cyclists must also be followed (see Mulga's safety guidelines).

GENERAL CONDUCT

Please behave on a Mulga tour much as you would when out to dinner: with respect and consideration for your fellow guests, as well as others around you.

- You must read, understand, and conform with the cycling safety instructions outlined in Mulga's safety guidelines.
- You must report any accidents, injuries, loss, or damage suffered during the tour **before** leaving the tour.
- Please represent cycling in a positive light. We require you to refrain from using bad language, spitting, snorting, and other anti-social behaviour when on a Mulga tour.
- You must behave with respect to other guests, tour operators, and accommodation and meal providers at all times. Discriminatory language or anti-social conduct will not be tolerated in any form.
- You must respect the tour operators' property and that of other guests and our accommodation and food providers. You are responsible for damage or loss you incur and are liable for replacement and repair costs.
- Littering is not tolerated at any time.
- You must keep noise to a minimum between 10pm and 7am.
- There will be plenty of food and wonderful wines and beers at our meals (drinks available at guests' expense) – please keep alcohol consumption to a reasonable level. Drunkenness or under-age drinking is not tolerated and may be referred to the police.
- You are not permitted to smoke within 25 metres of all Mulga Bicycle Tour vehicles and rest and meal stops.
- Bringing, consuming or possessing illicit drugs is strictly prohibited.
- Respect landowners. Please leave gates as you find them.
- We may be travelling through some quite remote country, but please remember that if nature calls, be discreet – consider other guests, road users, and the landowners whose property you may be tempted to put to use. We have planned comfort stops along the route so please check with us – it could well be the case that a luxurious toilet block is just minutes away.
